ELIGIBILITY:	<ul> <li>Open to all Virginia Swimming athletes and those by invitation registered before the first day of the meet</li> <li>No on deck Virginia Swimming athlete registration will be permitted</li> <li>Age on March 21, 2015 will determine age for the entire meet.</li> </ul>
DISABILTY SWIMMERS:	<ul> <li>Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.</li> <li>The athlete (or the athlete's coach) is also responsible for notifying the session referee of any</li> </ul>
	disability prior to the competition.
FORMAT:	All 11& under swimmers will swim on Saturday morning.
	All 12 & older swimmers will swim on Saturday afternoon.
	All events will be timed finals
	All 25 yard events will start from the turn end of the pool
	<ul> <li>Depending on the number of entries, the meet director reserves the right to combine the morning and afternoon sessions. Teams would be notified not later than Friday, March 13, 2015.</li> </ul>
WARM-UP:	Saturday Morning session: Warm-ups at 7:30 am; competition starts no earlier than 8:40 am.
	Saturday Afternoon session : Warm ups approx.11:00 am; competition starts approx. 12:00 pm
	Lane assignment and warm-up times for individual clubs will be posted on the BASS website <a href="www.BASS-Swim.org">www.BASS-Swim.org</a> no later than March 18, 2015, and will also be emailed to the contact person of the participating clubs.
	If any session runs late, the next session warm-ups will begin immediately upon its conclusion.
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS WEDNESDAY, MARCH 11, 2015
	• Entries must be submitted in short course yard times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.
	Teams submit entries via e-mail
	A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted.
	Coach's Times (CT) will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.

	"No Time" (NT) entries will not be accepted.
	Swimmers may enter a maximum of 4 individual events and 1 relay event per session.
	Relay teams must be designated A, B, C, etc., if more than one per club is entered per event.
	Entries will be processed in the order received and <u>accepted to</u> the greatest extent possible without exceeding the 4-hour/session timeline limit.
	The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which actions may require reseeding. Relays may be removed and relay entry fees refunded if necessary.

FEES:	Individual events: \$4.00
	Relay events: \$12.00 Swimmer surcharge: \$2.50 per person (entered in the meet in any capacity)
	Checks should be made payable to: BASS Swim Team.
	<ul> <li>Payment must be received by March 17, 2015 for email entries. All mailed entries must have the payment included with the entries.</li> </ul>
	Failure to pay entry fees by this deadline could result in teams being barred from the meet.
AWARDS:	Individual events: Ribbons will be awarded for first through sixth place.
	<ul> <li>12 &amp; over individual events will be given separate awards for 12-13, 14-15, and 16 &amp; over age groups.</li> </ul>
	<ul> <li>11 &amp; under individual events will be given separate awards for 10-11, 8-9, and 7 &amp; under age groups.</li> </ul>
	<ul> <li>8 &amp; under individual events will be given separate awards for 7-8 and 6&amp;U age groups.</li> </ul>
	<ul> <li>Heat winner ribbons will be awarded for all 8 &amp; under individual events.</li> </ul>
	Relay events: Ribbons will be awarded for first through fourth place.
SEEDING:	All events will be pre-seeded.
	<ul> <li>All 11 &amp; younger swimmers must report to the Clerk of Course and they will be brought to the blocks from there.</li> </ul>
	All swimmers 12 and older swimmers should report directly to the blocks for their events.
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times:
	<ul> <li>Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.</li> </ul>
	<ul> <li>Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.</li> </ul>
	Clubs entering swimmers not legally registered with United States Swimming before the first day of the meet may be fined \$100 per swimmer in each event so entered.
	If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	The current USA Swimming Rules and Regulations will apply.
	All swimmers in the meet must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water. If unaccompanied by a member coach, the swimmer or the swimmer's legal guardian must ensure compliance with this requirement.
	The overhead start procedure will be used for the afternoon sessions, and may be used for the morning sessions at the discretion of the Referee.
