| FEES: | Individual events: \$4.00 <br> Relay events: \$12.00 <br> Swimmer surcharge: $\$ 2.50$ per person (entered in the meet in any capacity) <br> - Checks should be made payable to: BASS Swim Team. <br> - Payment must be received by March 17, 2015 for email entries. All mailed entries must have the payment included with the entries. <br> - Failure to pay entry fees by this deadline could result in teams being barred from the meet. |
| AWARDS: | - Individual events: Ribbons will be awarded for first through sixth place. 12 \& over individual events will be given separate awards for 12-13, 14-15, and 16 \& over age groups. <br> - 11 \& under individual events will be given separate awards for $10-11,8-9$, and 7 \& under age groups. <br> - 8 \& under individual events will be given separate awards for 7-8 and 6\&U age groups. <br> - Heat winner ribbons will be awarded for all $8 \&$ under individual events. <br> - Relay events: Ribbons will be awarded for first through fourth place. |
| SEEDING: | - All events will be pre-seeded. <br> - All 11 \& younger swimmers must report to the Clerk of Course and they will be brought to the blocks from there. <br> - All swimmers 12 and older swimmers should report directly to the blocks for their events. |
| PENALTIES: | Penalties for entries using fraudulent and/or non-verifiable entry times: <br> - Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded. <br> - Club may be fined $\$ 100$ for each offense, and a record of such offenses shall be kept and published as part of the official meet results. <br> - Clubs entering swimmers not legally registered with United States Swimming before the first day of the meet may be fined $\$ 100$ per swimmer in each event so entered. <br> - If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. |
| RULES: | - The current USA Swimming Rules and Regulations will apply. <br> - All swimmers in the meet must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water. If unaccompanied by a member coach, the swimmer or the swimmer's legal guardian must ensure compliance with this requirement. <br> - The overhead start procedure will be used for the afternoon sessions, and may be used for the morning sessions at the discretion of the Referee. |
