| FORMAT: | - All 9-12 year old swimmers will swim in Saturday and Sunday morning session. <br> - All 8 \& Under swimmers will swim in the Saturday Midday session. <br> - The 400 IM and 500 Free for 13 \& Older swimmers will compete on Sunday Mid-day session. <br> - All 13 \& Older swimmers will swim on Saturday and Sunday afternoon session. <br> - All events will be timed finals |

| ENTRIES: | DEADLINE FOR THE RECEIPT OF ENTRIES IS 9:00 PM, WEDNESDAY, NOVEMBER 12, 2014. <br> - Entries must be submitted in short course yard times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet. <br> - Teams must submit entries via e-mail <br> - A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. <br> - Coach Times (CT) and "No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition. <br> - Swimmers may enter a maximum of 4 individual events on Saturday and Sunday. <br> - Entries will be processed in the order received and accepted to the greatest extent possible without exceeding the 4 -hour/session timeline limit. <br> - The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. | SEEDING: | - All events will be pre-seeded, except \#65-66 (9-12 500 Free), \#67-68 (13 and Over 400 Individual Medley), and \#69-70 (13 and Over 500 Free) which will be positive check in events. Positive check in will close at the completion of event 56 for events $65-66$. |  | be re-scored and awarded. <br> - Club may be fined $\$ 100$ for each offense, and a record of such offenses shall be kept and published as part of the official meet results. <br> - Clubs entering swimmers not legally registered with USA Swimming before the first day of the meet may be fined $\$ 100$ per swimmer in each event so entered. <br> - If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. |

| RULES: | - The current USA Swimming Rules and Regulations will apply. <br> - All swimmers participating in the meet must be certified by a USAS member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. <br> - The overhead start procedure will be used unless otherwise directed by the meet referee. <br> - Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited. <br> - Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms.
