FORMAT:	Events will be swum in a single session		
	All events will be timed finals.		
WARM-UP:	Warm-ups are at 9:00 am; competition starts at 10:00 am		
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS Friday, January 2, 2015		
	• Entries must be submitted in short course meters times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.		
	Teams submit entries via e-mail		
	 A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. 		
	"No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of record. All entry times must have been achieved in USA Swimming sanctioned, approved, or observed competition.		
	6 and under swimmers may swim a maximum of 4 events plus a relay. 7 and 8 year old swimmers may swim a maximum of 5 events plus a relay.		
	• Entries will be processed in the order received and <u>accepted to</u> the greatest extent possible without exceeding the 4-hour/session timeline limit.		
	The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which actions may require reseeding.

AWARDS:	Individual events: Ribbons will be awarded for first through sixth place in each event
	Awards will be given for each age group: 6 and under, 7 year olds and 8 year olds.
SEEDING:	All events will be pre-seeded.
	Swimmers should report directly to the blocks for their events.
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times:
	 Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.
	 Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.
	Clubs entering swimmers not legally registered with USA Swimming before the first day of the meet may be fined \$100 per swimmer in each event so entered.
	If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	The current USA Swimming Rules and Regulations will apply.
	 Any swimmer entered in the meet must be certified by a USAS member coach as being proficient in performing a racing dive or must start each race from within the water. If unaccompanied by a member coach, the swimmer or the swimmer's legal guardian must ensure compliance with this requirement.
	The overhead start procedure may be used at the discretion of the Referee.
	 Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u>.
	Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
	Swimmers should shower before entering the pool.
	 In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet
	 Coaches with valid USA Swimming credentials but are unable to provide them upon request will be issued temporary credentials by the meet director
	 Coaches with expired or non-current credentials will be required to leave the deck area.
