|            | <ul> <li>Clubs entering swimmers not legally registered with USA Swimming before the first day of the<br/>meet may be fined \$100 per swimmer in each event so entered.</li> </ul>   |
|            | If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.   |
| RULES:     | The current USA Swimming Rules and Regulations will apply.   |
|            | <ul> <li>Any swimmer entered in the meet must be certified by a USAS member coach as being proficient in<br/>performing a racing start or must start each race from within the water.
