

|                         | No on deck Virginia Swimming athlete registration will be permitted  |  |  |  |
|                         | Age on June 12, 2015 will determine age for the entire meet.   |  |  |  |
| DISABILITY<br>SWIMMERS: | Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.   |  |  |  |
|                         | <ul> <li>The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.</li> </ul>   |  |  |  |
| FORMAT:                 | Events will be swum in a single session  |  |  |  |

|                         | <ul> <li>Entries must be submitted in short course meters times using Hy-Tek Team Manager and Commlink-<br/>2 software, or on a VSI master entry sheet.</li> </ul>   |  |  |  |

|                         | <ul> <li>A Team Manager printout of entries must be included or the meet checklist/summary sheet with the<br/>name of the person to contact in case of questions must accompany the entries, regardless of how<br/>they are submitted.</li> </ul>  |  |  |  |
|                         | <ul> <li>"No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of<br/>record. All entry times must have been achieved in USA Swimming sanctioned, approved, or<br/>observed competition.</li> </ul>   |  |  |  |
|                         | • 6 and under swimmers may swim a maximum of 4 events plus a relay. 7 and 8 year old swimmers may swim a maximum of 5 events plus a relay.   |  |  |  |
|                         | <ul> <li>Entries will be processed in the order received and <u>accepted to</u> the greatest extent possible without<br/>exceeding the 4-hour/session timeline limit.</li> </ul>   |  |  |  |
|                         | • The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which actions may require reseeding.   |  |  |  |

|                         | <ul> <li>Deck entries will be accepted in the order received for swimmers already entered in the meet, to the extent that open lanes are available. |            | • <b>IMPORTANT:</b> If payment is sent via Express Mail/FedEx/Airborne/UPS/etc., please ensure that a signature is Not required for delivery as this will delay the receipt of your entries.   |
| AWARDS:    | Individual events: Ribbons will be awarded for first through sixth place in each event   |
|            | • Awards will be given for each age group: 6 and under, 7 year olds and 8 year olds.   |
| SEEDING:   | All events will be pre-seeded.   |
|            | Swimmers should report directly to the blocks for their events.  |
| PENALTIES: | Penalties for entries using fraudulent and/or non-verifiable entry times:  |
|            | • Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.  |
|            | <ul> <li>Club may be fined \$100 for each offense, and a record of such offenses shall be kept and<br/>published as part of the official meet results.</li> </ul>  |
|            | Clubs entering swimmers not legally registered with USA Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered.   |
|            | • If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.   |
| RULES:     | The current USA Swimming Rules and Regulations will apply.   |
|            | • Any swimmer entered in the meet must be certified by a USAS member coach as being proficient in performing a racing start or much start each race from within the water. When unaccompanied by a member coach, the swimmer or the swimmer's legal guardian is responsible for ensuring compliance with this requirement. |
|            | The overhead start procedure may be used at the discretion of the Referee.   |
|            | • Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u> .  |
|            | • Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.  |
|            | In accordance with VSI Best Practice, swimmers should shower before entering the pool.   |
|            | <ul> <li>In accordance with VSI Policy, only those coaches who have current, valid USA Swimming<br/>credentials will be permitted to act in a coaching capacity at this meet</li> </ul>  |
|            | <ul> <li>Coaches with valid USA Swimming credentials but are unable to provide them upon request will<br/>be issued temporary credentials by the meet director</li> </ul>  |
|            | <ul> <li>Coaches with expired or non-current credentials will be required to leave the deck area.</li> </ul>   |
