| | Chase starts may be used at the discretion of the meet referee | |
| WARM-UP: | Morning sessions: Warm-ups at 6:30am; competition starts not before 8:00am. | |
| | Afternoon sessions: Warm-ups not before 12:00pm; competition starts not before 1:00pm. | |
| | Distance session (800 Free): The pool will be opened for 15 min. of open warm-ups immediately following the finish of the afternoon session with competition starting 5 min. thereafter. | |
| | The approximate start time for the distance sessions will be posted on the RAYS website, no later than Tuesday, July 7, 2015, and will also be emailed to the contact person of the participating clubs. | |

| | A Team Manager printout of entries must be included or the VSI meet summary sheet (available at VSI website, <u>www.virginiaswimming.org</u>) with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. | |

| AWARDS: | Individual events will be scored and awarded medals 1st through 3rd place and ribbons 4th through 16th place. |

| SEEDING: | All events, except the 400 and 800 freestyles, and the 400 IM's will be pre-seeded. |
| | The above events will require a positive check-in to swim. |
| | Positive check-in will close at 8:00am Friday, for event #17-18. |
| | Positive check-in will close at 1:00pm Friday, for event #25-26. |
| | Positive check-in will close at 8:00am Saturday, for event #47-48. |

| | SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT. |
| | Events 87 & 88 (800 Freestyle) will be swum fastest to slowest and alternating heats of girls and boys. |
| PENALTIES: | Penalties for entries using fraudulent and/or non-verifiable entry times: |
| | Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded. |
| | Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results. |
| | Clubs entering swimmers not legally registered with USA Swimming before the first day of the meet may be fined \$100 per swimmer in each event so entered. |
| | If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. |
| | A \$50 fine will be levied against any swimmer who positively checks-in and declares their intent to swim for a distance event and does not show up to compete. |
| RULES: | The current USA Swimming Rules and Regulations will apply. |
| | Any swimmer entered in the meet must be dive certified by a USAS member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. |
| | The overhead start procedure will be used for all sessions, and may be used for all sessions at the discretion of the Referee. |
| | Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is not permitted. |
| | Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited. |
| | In accordance with VSI Best Practices, swimmers should shower before entering the pool. |
| | In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet |
| | Coaches who have valid USA Swimming credentials but who are unable to provide them upon request will be issued temporary credentials by the meet director |
| | Coaches with expired or non-current credentials will be required to leave the deck area. |

| | • Spectator Seating : May not be reserved and saving of seats is not allowed. No coolers larger than a 6 pack lunch box will be allowed in the stands. Swim bags can not be brought into the spectator bleachers. |
