ELIGIBILITY:	<ul style="list-style-type: none">• Open to all USA Swimming registered swimmers• All swimmers participating in this meet must be registered by the first day of the meet.• No on deck registration will be permitted.• Age on May 5, 2007 will determine the swimmer's age for the meet
DISABILITY SWIMMERS:	<ul style="list-style-type: none">• Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
FORMAT:	<ul style="list-style-type: none">• All 13 & Older swimmers will swim on Saturday and Sunday Morning.• All 12 & Younger swimmers will swim on Saturday and Sunday afternoon.• All events will be timed finals.
WARM-UP:	<ul style="list-style-type: none">• Morning sessions: Warm-ups at 6:30, competition starts at 8:10.• Afternoon sessions: Warm-ups at 12:00, competition starts at 1:40.• Distance sessions:<ul style="list-style-type: none">○ The approximate start time for the distance sessions will be posted on the QDD Swim Team website no later than May 4, 2007, and will also be emailed to the contact person of the participating clubs.○ The distance sessions will start no earlier than the estimated times.• If the morning session runs late, afternoon warm-ups will begin immediately after the morning session ends.• Lane assignment and warm-up times for individual clubs will be posted on the QDD website no later than May 1, 2007, and will also be emailed to the contact person of the participating clubs.• If the morning session runs late, afternoon warm-ups will begin immediately after the morning session ends.
ENTRIES:	<p>DEADLINE FOR THE RECEIPT OF ENTRIES FOR VSI TEAMS IS 6:00 PM, WEDNESDAY, APRIL 25, 2007</p> <ul style="list-style-type: none">• Entries from teams outside the VSI LSC will be accepted until 6:00 pm, Thursday, April 28, 2007, if space is available after VSI entries have been accepted.• Entries must be submitted in LC Meter times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.• Teams may submit entries as an e-mail attachment (preferred) or on a 3 ½" computer disk.• A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name, email address, and phone number of the person to contact in case of questions must accompany the entries, regardless of how they are submitted.• Coaches Times (CT) will be accepted except where specified for events in which a swimmer does not have a time of record. Coaches' times may not exceed a "B" time. All entry times other than Coaches Times must have been achieved in USA Swimming sanctioned or approved competition.

	<ul style="list-style-type: none"> • “No Time” (NT) entries will not be accepted. • Swimmers may enter a maximum of 3 individual events per session and 4 individual events per day. If a swimmer exceeds the maximum entries, the last event, by numerical order, will be dropped. • Entries will be processed in the order received. This meet will be limited to a total of 750 Swimmers. <ul style="list-style-type: none"> ○ Sessions #1 #3, #4 and #5 (SAT & SUN Mornings and Afternoons) are limited to a maximum of 350 swimmers per session. ○ Entries in events #13 & #14 (13&O 800m Free) are limited to a maximum of 2 hours. ○ Entry into events #13 & #14 is limited to those swimmers who have a time of record equal to B or faster time in the 500 Free, for their current age group. No Coaches Times. ○ Entry into events #53 & #54 (12&Y 400m Free) is limited to those swimmers who have a time of record equal to B or faster time in the 500 Free, for their current age group. No Coaches Times. • The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. If received prior to the printing of the heat sheet, the swimmer will be seeded into the event; if after, they will go in the slowest heat in an empty lane. Additional heats will not be added.

Payment must be included with all mailed entries. • Failure to pay entry fees by this deadline could result in teams being barred from the meet.
AWARDS:	<ul style="list-style-type: none"> • Individual events: Ribbons will be awarded for first through 8th Place. • 13 & Older events will be given separate awards for 13-14, and 15 & Older age groups. • 12 & Younger events will be given separate awards for 11-12, 9-10 and 8 & Younger age groups.
SEEDING:	<ul style="list-style-type: none"> • All events, except events 11, 12 (400 IM), 13, 14 (800 Free), 39, 40, 53, 54 (400 Free) will be pre-seeded • Positive check-in is required for all events 400m and longer. <ul style="list-style-type: none"> ○ Session #1: By 8:30 am SAT, May 5th for #11, #12. ○ Session #2: By 10:00 am SAT May 5th, for #13 & #14. ○ Session #4: By 8:30 am SUN, May 6th for #39, #40. ○ Session #6: By the end of warm-ups of Session #5 SUN, May 6th for #53, #54. • SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT • Swimmers competing in the 800 free are responsible for providing their own lap counters and timers. • Events 13, 14 (800 Freestyle) will be swum fastest to slowest and alternating heats of girls and boys. • Competition will be conducted in 9 lanes for events #13 & #14, leaving ONE lane open for continuous warm-up & cool-down.

PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times: <ul style="list-style-type: none"> • Swimmer shall be disqualified from the event entered illegally and the event shall be re-scored and awarded. • Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results. • Clubs entering swimmers not legally registered with United States Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered. • If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. 		
RULES:	<ul style="list-style-type: none"> • The current USA Swimming Rules and Regulations will apply. • The overhead start procedure will be used for all sessions. • In accordance with VSI Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

SAFETY:	VSI Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the Meet Referee, any swimmer, coach, or club for the failure to follow the safety rules.		
TIMERS:	<ul style="list-style-type: none"> • Clubs will be required to provide timers in proportion to the number of swimmers they have entered in each session. • The number of timers required per club and their lane assignments will be posted on the www.pwcweb.com/qddsims no later than May 3rd, and will also be emailed to the contact person of each of the individual clubs. 		
GENERAL:	<ul style="list-style-type: none"> • Heat sheets will be sold for \$5. • A Hospitality Suite will be available (refreshments & lunch) for USS officials & coaches. • Concessions snack bar and PRO SHOP will be available. • Refreshments, lunch and evening snacks will be provided for USS officials & coaches 		
FACILITY RULES:	<ul style="list-style-type: none"> • Each club is responsible for supervising the conduct of their swimmers. • Swimmers are not permitted in any room of the buildings not directly associated with this swim meet. • No towels or suits etc. are to be hung on or around the lifeguard stands. • Only coaches, swimmers, and officials are allowed on the competition deck. All others are required to be in the elevated spectator bleachers or in the hallway. • Contact the Freedom Center Staff, (703) 993-8444, to request group rate use of the entire facility for your non swimming children/adults (\$3/person) • No cars are to be left in the fire lanes.
