	<p>2 software, or on a VSI master entry sheet.</p> <ul style="list-style-type: none"> • Teams submit entries via e-mail • A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. • Coach's Times (CT) will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition. • "No Time" (NT) entries will not be accepted. • 9 & Older Swimmers may enter a maximum of 3 individual events and 1 relay event per session. 11 & Older swimmers may compete in 1 additional event in the Saturday Middle Distance session. • 8 & younger swimmers may enter a maximum of 4 individual events and 1 relay event in the Sunday 8&U Middle Session. • Relay teams must be designated A, B, C, etc., if more than one per club is entered per event. • Entries will be processed in the order received and accepted to the greatest extent possible without exceeding the 4-hour/session timeline limit. • The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session.
