<b>FACILITY:</b>	<ul style="list-style-type: none"><li>• 25 Yard, 6 Lanes, indoor pool with non-turbulent lane lines, 4 feet in depth at the start end and 13 ½ feet in depth at the turn end; Colorado Timing System with a six-line digital display board.</li><li>• The competition course has not been certified in accordance with current <i>USA Swimming Rules and Regulations</i>, Article 104.2.2(C).</li></ul>

<b>ELIGIBILITY:</b>	<ul style="list-style-type: none"><li>• Open to all Virginia Swimming athletes in the North District and the Southwest District and those by invitation registered by the first day of the meet.<ul style="list-style-type: none"><li>○ North District Teams are: BASS, PWSC, QDD, RAPP, RAYS, RPST, SHKS, STAT, TSU, VAST, VSTP, &amp; WST</li><li>○ Southwest District Teams are: ACST, CAST, CCA, CYAC, FUAC, GATR, GRD, HA, HOKI, LASO, LY, SCAT, SMAC, STRM, &amp; SVFY.</li></ul></li><li>• No on deck Virginia Swimming athlete registration will be permitted</li><li>• Age on March 19, 2011 will determine age for the entire meet.</li></ul>
<b>DISABILITY SWIMMERS:</b>	<ul style="list-style-type: none"><li>• Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.</li><li>• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.</li></ul>
<b>FORMAT:</b>	<ul style="list-style-type: none"><li>• All 9-12 swimmers will swim on Saturday and Sunday morning.</li><li>• All 13 &amp; Older swimmers will swim on Saturday and Sunday afternoon.</li><li>• All 8 &amp; younger swimmers will swim in the Saturday Middle 8&amp;U Session</li><li>• Sunday Middle Distance Session is for 11 &amp; Older swimmers only.</li><li>• All events will be timed finals.</li><li>• <b>Depending on the number of entries, the meet director reserves the right to change the format of the meet to include combining, adding or eliminating sessions. Teams would be notified not later than Wednesday, March 16, 2011</b></li></ul>
<b>WARM-UP:</b>	<ul style="list-style-type: none"><li>• Saturday Morning session: Warm-ups at 7:30 am; competition starts at 8:40 am.</li><li>• Saturday Middle 8&amp;U session: Warm-ups at 11:45 pm; competition starts at 12:35 pm.</li><li>• Saturday Afternoon session : Warm ups at 2:30 pm; competition starts at 3:30 pm</li><li>• Sunday Morning session: Warm ups at 7:30 am; competition starts at 8:40 am</li><li>• Sunday Middle Distance session: Warm ups at 11:45; competition starts at 12:00 pm</li><li>• Sunday Afternoon session: Warm ups at 1:00 pm; competition starts at 2:00 pm</li><li>• Lane assignment and warm-up times for individual clubs will be posted on the BASS website <a href="http://www.BASS-Swim.org">www.BASS-Swim.org</a> no later than March 16, 2011, and will also be emailed to the contact person of the participating clubs.</li><li>• If any session runs late, the next session warm-ups will begin immediately upon it's conclusion.</li><li>• <b>Depending on the number of entries, the meet director reserves the right to change the start time and format of warm-ups. Teams would be notified not later than Wednesday, March 16, 2011</b></li></ul>
<b>ENTRIES:</b>	<b>DEADLINE FOR THE RECEIPT OF ENTRIES IS WEDNESDAY, MARCH 9, 2011</b> <ul style="list-style-type: none"><li>• Entries must be submitted in short course yard times using Hy-Tek Team Manager and Commlink-</li></ul>

	<p>2 software, or on a VSI master entry sheet.</p> <ul style="list-style-type: none"> <li>• Teams submit entries via e-mail</li> <li>• A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted.</li> <li>• Coach's Times (CT) will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.</li> <li>• "No Time" (NT) entries will not be accepted.</li> <li>• <b>9 &amp; Older Swimmers may enter a maximum of 4 individual events and 1 relay event per session. 11 &amp; Older swimmers may compete in 1 additional event in the Sunday Middle Distance session.</b></li> <li>• <b>8 &amp; younger swimmers may enter a maximum of 4 individual events and 1 relay event in the Saturday 8&amp;U Middle Session.</b></li> <li>• Relay teams must be designated A, B, C, etc., if more than one per club is entered per event.</li> <li>• Entries will be processed in the order received and <b>accepted to</b> the greatest extent possible without exceeding the 4-hour/session timeline limit.</li> <li>• The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. <b>FEES:</b>	<p>Individual events: \$3.00 Relay events: \$12.00 Swimmer surcharge: \$2.50 per person (entered in the meet in any capacity)</p> <ul style="list-style-type: none"> <li>• Checks should be made payable to: <b>BASS Swim Team.</b></li> <li>• <b>Payment must be received by March 16, 2011 for email entries. All mailed entries must have the payment included with the entries.</b></li> <li>• Failure to pay entry fees by this deadline could result in teams being barred from the meet.</li> </ul>
<b>AWARDS:</b>	<ul style="list-style-type: none"> <li>• Individual events: Ribbons will be awarded for first through sixth place. <ul style="list-style-type: none"> <li>○ 13 &amp; over individual events will be given separate awards for 13-14, and 15 &amp; over age groups.</li> <li>○ 11 &amp; over individual events will be given separate awards for 11-12, 13-14, and 15 &amp; over age groups</li> <li>○ 9-12 individual events will be given separate awards for 9-10 and 11-12 age groups.</li> <li>○ 8 &amp; under individual events will be given separate awards for 6&amp;U and 7-8 age groups.</li> <li>○ Heat winner ribbons will be awarded for all 8 &amp; under individual events.</li> </ul> </li> <li>• Relay events: Ribbons will be awarded for first through fourth place.</li> </ul>
<b>SEEDING:</b>	<ul style="list-style-type: none"> <li>• All events will be pre-seeded.</li> <li>• All 12 &amp; younger swimmers must report to the Clerk of Course and they will be brought to the blocks from there.</li> <li>• All swimmers 13 and older swimmers should report directly to the blocks for their events.</li> </ul>
<b>PENALTIES:</b>	<p>Penalties for entries using fraudulent and/or non-verifiable entry times:</p> <ul style="list-style-type: none"> <li>• <b>Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.</b></li> <li>• <b>Club may be fined \$100 for each offense, and a record of such offenses shall be kept and</b></li> </ul>
