ELIGIBILITY:	<ul style="list-style-type: none">• Open to all Virginia Swimming athletes registered by the first day of the meet• No on deck Virginia Swimming athlete registration will be permitted.• 8 years old & Younger swimmers may participate regardless of classification in 8 & Under events.• Swimmers 9-18 years old may compete in any event and relay strokes in which they have a "BB", "B" or "C" Time.• 2009-2012 NAG times are in effect• Age on December 4, 2010 will determine age for the entire meet.
DISABILITY SWIMMERS:	<ul style="list-style-type: none">• Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
FORMAT:	<ul style="list-style-type: none">• All 10 & Younger swimmers will swim on Saturday and Sunday morning.• All 11 & Older swimmers will swim on Saturday and Sunday afternoon.• There will be a distance session following the morning and afternoon sessions on Sunday.• All events will be timed finals.
WARM-UP:	<ul style="list-style-type: none">• Morning sessions: Warm-ups at 8:30 am; competition starts at 9:40 am.• Afternoon sessions: Warm-ups at 12:30 pm; competition starts at 1:40 pm.• Distance sessions: The pool will be opened for 10 minutes of open warm-ups immediately following the finish of the Sunday morning and afternoon session(s), with the distance session competition starting 5 minutes thereafter.• The approximate start time for the distance sessions will be posted on the Virginia Gators website no later than December 1, 2010 and will also be emailed to the contact person of the participating clubs. The distance sessions will start no earlier than the estimated times.• Lane assignment and warm-up times for individual clubs will be posted on the Virginia Gators website no later than December 1, 2010 and will also be emailed to the contact person of the participating clubs.• If the morning session runs late, afternoon warm-ups will begin immediately after the morning session ends.• Depending on the number of entries, the meet director reserves the right to change the start time and format of warm-ups. Teams would be notified not later than Wednesday, December 1, 2010.
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS THURSDAY, NOVEMBER 25, 2010 <ul style="list-style-type: none">• Entries must be submitted in short course yard times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.

	<ul style="list-style-type: none"> Teams submit entries as an e-mail attachment. A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. Coach's Time (CT) and "No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition. Swimmers may enter a maximum of 4 <i>individual events</i> and 1 <i>relay event</i> per day. Relay teams must be designated A, B, C, etc., if more than one per club is entered per event. Entries will be processed in the order received and accepted to the greatest extent possible without exceeding the 4-hour/session timeline limit. The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which actions may require reseeding. Deck entries will be accepted in the order received for swimmers already entered in the meet, to the extent that open lanes are available. No additional heats will be added. Deck entries must be submitted to the Clerk-of-Course on the provided forms.
FEES:	<p>Individual events: \$3.00 Relay events: \$12.00 Swimmer surcharge: \$2.50 per person (entered in the meet in any capacity)</p> <ul style="list-style-type: none"> Checks should be made payable to: Virginia Gator Swimming. Payment must be received by December 4, 2010 for email entries. Payment must be included with all mailed entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
AWARDS:	<ul style="list-style-type: none"> Individual events: Ribbons will be awarded for first through eighth for all 12 & Under events. <ul style="list-style-type: none"> 8 & Under events will be awarded as 6 & Under, 7 yr olds and 8 yr. olds. 10 & Under events will given separate awards for 8 & Under and 9-10 age groups. 11 & Over events will be given awards for the 11-12 age group only
SEEDING:	<ul style="list-style-type: none"> All events, except events except Events 61-62 (10&U 500 Free) and Events 83-84 (11&O 500 Free) will be pre-seeded. 8 & Younger swimmers in the morning sessions must report to the Clerk of Course and they will be escorted to the blocks from there. Swimmers in the afternoon sessions should report directly to the blocks for their events. Events 61-62 (10&U 500 Free) and Events 83-84 (11&O 500 Free) will require a positive check-in to swim. Positive check-in will close at the end of each session's warm-up on the days of the 500 free. SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT.
PENALTIES:	<p>Penalties for entries using fraudulent and/or non-verifiable entry times:</p> <ul style="list-style-type: none"> Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded. Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results. Clubs entering swimmers not legally registered with United States Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered. If the swimmer is representing a club in competition, the fine will be levied on the Club. If the

	swimmer is unattached, the fine will be levied on the swimmer.
RULES:	<ul style="list-style-type: none"> • The current USA Swimming Rules and Regulations will apply. • Swimmers in the meet, unaccompanied by a USA-S coach must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water. Ensuring compliance is the responsibility of the swimmer or the swimmer's legal guardian. • The overhead start procedure will be used for the afternoon sessions, and may be used for the morning sessions at the discretion of the Referee. • In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

SAFETY:	<ul style="list-style-type: none"> • VSI Safety and Warm-up procedures will be in effect.
TIMERS:	<ul style="list-style-type: none"> • Clubs will be required to provide timers in proportion to the number of swimmers they have entered in each session. • The number of timers required per club and their lane assignments will be posted on the Virginia Gators website no later than December 1, 2010 and will also be emailed to the contact person of each of the individual clubs.
GENERAL:	<ul style="list-style-type: none"> • Complimentary lunch will be served for coaches, referees, starters stroke & turn judges, timing judges, clerk of course, CTS operators and recorder. • A concession stand will be available for swimmers and spectators. • No other major activities will be taking place at the Gator Aquatic Center on December 4-5, except this swim meet. • Results will be posted on the wall at the turn end of the pool. • Complimentary heat sheets will be provided for officials and coaches. Heat sheets will also be sold for \$5.00 each. • Meet information can be found at www.virginiagators.com
