COURSE DESCRIPTION	Open water: The race course will consist of a 500M loop marked with large orange buoys. There will be a beach start at the start/finish line. Finish Banner marks finish line. Manual watches will be used for timing system.
	All swimmers who have not completed the course during the prescribed time limit will be asked to retire.
	 200M RACE will swim 100M parallel to the shore out and back marked with red and yellow colored buoys.
	Details of race course with landmarks will be available at check-in.
	Expected water temperature is Low 70's degrees

ELIGIBILITY:	• Open to all USA Swimming athletes age 7 and older registered prior to the first day of the meet.
	 Must be registered USA swimmer to enter. Single day event membership available for an additional \$12 (registration form can be found on the last page of this announcement.
	• All swimmers who are registered with a USA Swimming Club may enter a relay if they are entered in an individual event.
	No at location registration will be permitted.
	Age on May 19, 2012 will determine age for the entire meet.
	Race day entries will be accepted with prior USA Swimming registration.
DISABILITY SWIMMERS:	 Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.
	• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
FORMAT:	Morning session will be for Open, and 15-18 3K events
	Afternoon session will be for Open and 11-12 and 13 -14 2K events
	 Late Afternoon session will be for Open and 7-12 500M events, 8&U 200M event, and relay events.
WARM-UPS:	Morning sessions: Warm-ups at 9:00 AM, competition starts at 10:00 AM.
	• Mid-morning session: Warm-ups at 11:00 AM, competition starts at no earlier than 12:30 PM.
	• Afternoon sessions: Warm-ups at 12:30 PM, competition starts at no earlier than 1:30 PM.
	• Depending on the number of entries, the Meet Director reserves the right to change the start time and format of warm-ups. Teams will be notified not later than Tuesday, May 15, 2012.
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS FRIDAY, MAY 11, 2012
	 Entries must be submitted in LCM times using Hi-Tech Team Manager and Commlink-2 software, or on a VSI master entry sheet.
	Teams may submit entries via e-mail.
	 A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name, phone number, and email address of the person to contact in case of questions must

	accompany the entries, regardless of how they are submitted.
	• Coach's Time (CT) and "No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.
	• Swimmers may enter a maximum of 3 <i>individual events</i> and 2 <i>relay events</i> per day.
	• Relay teams must be designated A, B, C, etc., if more than one per club is entered per event.
	Entries will be processed in the order received. This meet will be limited to a total of 400 swimmers
	• The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which actions may require reseeding.

	• IMPORTANT: If entries are sent via Express Mail/FedEx/Airborne/UPS/etc., please ensure that a signature is NOT required for delivery as this will delay the receipt of your entries.
	• Deck entries will be accepted in the order received for swimmers to the extent that they can be processed prior to check-in.
FEES:	Individual events: \$16 first individual event, \$8 each additional event
	Relay events:\$20 per relaySwimmer Surcharge:\$20 (entered in any capacity in the meet includes cap and t-shirt)
	 All entries received after May 11, 2012 may require a \$5 late fee per swimmer.

	• Payment must be received by May 11, 2012 for all entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
AWARDS:	• Age Group Individual Events: Medals will be awarded to first to third place for each age group/gender event. Ribbons for fourth to eighth place by age group/gender. Events 19 and 20 will be divided out and scored by 8 & U, 9-10 and 11-12.
	Age Group Relays: Medals will be awarded to first to third place only.
	• Open Individual Events: Medals will be awarded for first to third place for each open event by gender. Ribbons for fourth to eighth place by gender.
	Open Relay: Medals will be awarded to first to third place only.
	• Team Trophies will be awarded for first to third place. Scoring is as follows:
	 Individual events will be scored first to eighth place with the following points: 10-8-6-5- 4-3-2-1.
	 Relay events will be scored first to eighth place with the following points: 20-16-12-10- 8-6-4-2.
SEEDING:	• All like-distances will be seeded as a single event, without regard to a swimmer's age or gender. Places, awards, and published results will be separate for each event, age group, and gender.
	• Positive check-in for each event is listed on the Description of Events and Schedule page (page #6).
	• SWIMMERS FAILING TO POSITIVELY CHECK-IN WILL NOT BE ALLOWED TO SWIM THE EVENT.
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times:
	• Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.
	• Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.
	• Clubs entering swimmers not legally registered with USA Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered.

	• If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	The current USA Swimming Rules and Regulations will apply.
	All swimmers participating in the meet must be dive certified.
	 Swimmers unaccompanied by a USA-S coach must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water.
	o Ensuring compliance is the responsibility of the swimmer or the swimmer's legal guardian.
	Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms.
	In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet
	 Coaches who have valid USA Swimming credentials but who are unable to provide them upon request will be issued temporary credentials by the meet director
	Coaches with expired or non-current credentials will be required to leave the deck area.

	Officials will be needed for all positions and all sessions for this meet.
	• Officials that are comfortable and want to be out on the water, please state so in your request.
	• Team Officials Chairpersons should submit the names and session availability of certified officials, as well as the names and session availability of trainees to Gordon R Hair no later than May 11, 2012.
	Officials meeting will be at 9:00 AM at the hospitality tent.
SAFETY:	• The meet is a beach start with swimmers held in a closed area marked by numbers on
	swim cap, shoulders, back and front of one leg.
	 They will hold a card with the same number and will give this card to the chief sweep judge prior to the start of the race
	 The number of each swimmer will be recorded and delivered to each stroke and turn judge prior to the start of race.
	 There will be instructions of the course and rules of play to swimmers, then the start. At each turn, there will be an accounting of the swimmers by S/T and sweep judge (3 on the water and one on land).
	 Any one leaving the course will be accounted for and communicated to the chief sweep judge. When the swimmers finish it will be a beach finish and the swimmers will again be held in the closed starting area until the cards are returned to each swimmer.
	Monitoring Swimmers During Race
	 Safety boats will monitor the entire course, (2 power boats, one at each end or out of bounds of course, with 4 safety canoes and 3 safety jet Skis)
	• 4 Lifeguards will be on location, (2 in the water on Jet Skis and 2 on the land with view of entire course.
	 There will be one rescue/evacuation Jet Boat and one rescue/evacuation Jet Ski with EMT and Life Guard on Jet Ski.
	• The County Sheriff Department will be on site with Jet Ski or Boat and a Patrol on land.
	Medical Services
	 There will be a First Aid station/ tent available at start/finish beach.
	 The Mineral Rescue Squad will be on site with one ALS team and one BLS team. Located at the Start/Finish beach. Back up rescue squad will be Louisa County Fire Rescue 6 miles away.
	 UVA Pegasus on call and rescue landing site is 2 miles from event on corner of Route 522/Rt 208 response 5 minutes. Back up VA Hwy Patrol Chopper from Fredericksburg response time 5 minutes.
	 Hospital Emergency room Culpeper 20 minutes and 2 in Charlottesville 30 minutes.

	Safety Communications Plan
	 Safety communications Fian Each official and safety officer will have a radio and air horn, each safety stations will have a whistle, One Radio channel will be devoted to safety. One blast on whistle or one blast on air horn to attract attention then radio explanation of safety need.
	 The Safety Officer will be in charge of all safety at the event, overseeing life guards, EMT's and swims safety. The safety officer will be in contact with officials, life guards and EMT's by radio.
	 The safety officer will also have a Golf Cart and driver to be able to move through out the event quickly and where needed.
	Feeding Stations
	 The course is 500M and feeding stations are not required; however, there will be 6 safety stations and each will have first aid and water.
	 There will not be escort for swimmers but there will be 6 safety stations viewing each swimmer and accounting of each swimmer 4 times each lap as they pass each S/T on course.
	Accounting for swimmers
	 <u>Refer to monitoring swimmers</u>
	 'This is the most important duty of the safety team.
	 Each S/T official will ring bell if there is a DQ in their jurisdiction and follow with radio protocol also radio when last swimmer passes there station each lap.
	<u>Technical Meeting</u>
	 The technical Meeting will be held at 8 AM to 9 AM day of race. This technical Meeting will be posted and emailed to each team prior to meet day. This will also be review with each heat prior to start of each race.
	 Safety during pre-race warm-up and post-race warm-down
	 There will be a separate warm up warm down area and swimmers will not be allowed to warm up or warm down on the course.
	 The warm up area will also have at least one life guard and one marshal in addition we will have at least one canoe on water to prevent any swimmers beyond buoy markings of warm up course.
	 We will also require the swimmer to give their number card to marshal prior to entering warm- up area and pick up the card when leaving the warm-up area.
TIMERS:	Timers will be provided by the host team using recording watches.
GENERAL:	This event is on the public side of Lake Anna and will be held rain or shine.
	Event may be delayed or cancelled due to lightning. No refunds.
	Average water temperature is expected to be in the low 70s
	• Extra T-shirts for coaches and spectators may be ordered on your registration form for \$10 each.
	Rivanna Gear & Apparel will be on site for your swimming needs. Meet T Shirts may be purchased on site while quantities last.
	Hospitality tent will be set up by the lake with water coolers available for swimmers.
FACILITY RULES:	• There is a \$10 parking fee per car for non-camping participants and coaches collected by the campground at the gate day of the event. We highly recommend you carpool or sign up to camp.

DESCRIPTION OF EVENTS AND SCHEDULE

3K: The race will consist of 6 times around a 500m loop marked with large orange buoys. The race will End 90 minutes after the start. All swimmers who have not completed the course will be asked to retire. Check-in: 9:00 AM; Pre-race Meeting: 9:45 AM; Event starts: 10:00 AM.

2K: The race will consist of 4 times around a 500m loop marked with large orange buoys. The race Will end 60 minutes after the start. All swimmers who have not completed the course will be asked to Retire. Check-in: 10:05 AM; Pre-race Meeting: 11:15 AM; Event starts: No earlier than 11:30 AM.

1K: The race will consist of 2 times around a 500m loop marked with large orange buoys. The race will End 30 minutes after the start. All swimmers who have not completed the course will be asked to retire. Check-in: 11:00 AM; Pre-race Meeting: 12:15 Noon; Event start: No earlier than 12:30 PM

1/2 K: The race will consist of a 500m swim. The course will be a 500M marked with large orange Buoys. Check-in: 12:30 PM; Pre-race meeting: 1:15 PM; Event start: No earlier than 1:00 PM

200M: This race will consist of a straight 100m swim out and back. Check-in 12:45 PM; Pre-race Meeting: 1:00 PM; Event starts: No earlier than 1:15 PM.

Relays: All relays will swim 4 X 200m with a beach start/finish. Mixed relays must contain at least 1 Swimmer of each sex. Graduated Relay must contain 1 swimmer from each age group: 10 and U, 11-12, 13-14, 15-18. Relay members must touch their teammate prior to the next swimmer leaving the Starting line.
