All entry times must have been achieved in USA Swimming sanctioned, approved, or observed competition.6 and under swimmers may swim a maximum of 4 events plus a relay. 7 and 8 year old swimmers may swim a maximum of 5 events plus a relay.Entries will be processed in the order received and accepted to the greatest extent possible without exceeding the 4-hour/session timeline limit.The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. AWARDS:	<ul style="list-style-type: none"> • Individual events: Ribbons will be awarded for first through sixth place in each event • Awards will be given for each age group: 6 and under, 7 year olds and 8 year olds.
SEEDING:	<ul style="list-style-type: none"> • All events will be pre-seeded. • Swimmers should report directly to the blocks for their events.
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times: <ul style="list-style-type: none"> • Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded. • Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results. • Clubs entering swimmers not legally registered with USA Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered. • If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	<ul style="list-style-type: none"> • The current USA Swimming Rules and Regulations will apply. • All swimmers participating in the meet must be dive certified. <ul style="list-style-type: none"> ○ Swimmers unaccompanied by a USA-S coach must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water. ○ Ensuring compliance is the responsibility of the swimmer or the swimmer's legal guardian. • The overhead start procedure may be used at the discretion of the Referee. • Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u>. • Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged. • In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet <ul style="list-style-type: none"> ○ Coaches with valid USA Swimming credentials but are unable to provide them upon request will be issued temporary credentials by the meet director ○ Coaches with expired or non-current credentials will be required to leave the deck area.
