FACILITY:	<ul> <li>Outdoor 8-lane, 50 meter pool, 13 feet deep at the start end and 3.5 feet deep at the turn end of the pool with Kiefer Wave Eater lane lines. The course will be swum in 6 lanes with 2 lanes of continuous warmup during the event.</li> <li>Limited concrete deck space, but ample amounts of grassy area for tents and canopies.</li> <li>Colorado Timing System will be used.</li> <li>The competition course has not been certified in accordance with current USA Swimming</li> </ul>

ELIGIBILITY:	Open to all USA Swimming athletes registered prior to the first day of the meet.
	No on deck USA Swimming athlete registration will be permitted.
	Age on June 29, 2013 will determine age for the entire meet.
DISABILITY SWIMMERS:	Athletes with a disability are welcomed and shall provide advance notice of desired accommodations to the Meet Director.
	The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
FORMAT:	There will be only one event, the Open Mixed 1500 meter freestyle
	All events will be timed finals.
WARM-UP:	Warm-ups at 7:00 am; competition starts at 7:30 am.
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS Friday June 28, 2013.
	<ul> <li>Entries must be submitted in long course meter times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.</li> </ul>
	Coach Times (CT) will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.
	"No Time" (NT) entries will be accepted.

FEES:	There are no fees for this meet.
AWARDS:	There are no awards for this meet.
SEEDING:	All swimmers will be pre-seeded based on entry time.
PENALTIES:	Clubs entering swimmers not legally registered with USA Swimming by the first day of the meet may be fined \$100 per swimmer in each event so entered.
	If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	The current USA Swimming Rules and Regulations will apply.
	All swimmers participating in the meet must be dive certified.
	<ul> <li>Swimmers unaccompanied by a USA-S coach must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water.</li> </ul>

	<ul> <li>Ensuring compliance is the responsibility of the swimmer or the swimmer's legal guardian.</li> </ul>
	The overhead start procedure will be used for all sessions at the discretion of the Referee.
	Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms, or locker rooms. In addition, photography behind the blocks is not permitted.
	Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged.
	In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet
	<ul> <li>Coaches with valid USA Swimming credentials but are unable to provide them upon request will be issued temporary credentials by the meet director</li> </ul>
	<ul> <li>Coaches with expired or non-current credentials will be required to leave the deck area.</li> </ul>
	No VSI non-athlete member in good standing may be barred from participating in the meet as an official at any level to which certified.
