### **On-line Officials Test**

The new testing facility is live and available for use by all LSC's and officials. Information has been sent to all LSC Officials Chairs about how the facility works and how to gain access to the site for LSC certification testing. Among the features of the test facility is the ability to start the test, save it and continue it at a later date.
