Last call for all officials who were "grandfathered" at the N2 or N3 certification level: these certifications expired on December 31, 2007. If you have not recertified by March 31, you will be dropped one level.

Certification Updates

A number of documents on the Certification pages of the Officials section of the USA Swimming Web site, have been revised to better reflect the use of the online Officials Tracking System (OTS). In particular, the FAQ's have been edited to include some additions and some no longer relevant questions and answers have been deleted.

So far this year 65 meets have been approved as "Officials Qualifying Meets" while over 700 applications for recertification in and, or, advancement to N2 and N3 positions have been submitted and processed through the OTS. Please remember that it may take a week or two for the approval to be processed into the membership database and for a card to be mailed.

Situation

During the Girls 10& Under 200-Yard Medley Relay Final at a Championship Meet the breaststroke swimmer completes her leg, exits, and then sits on the edge of the pool with her feet dangling in the water. In the excitement of cheering her team to an upset win she inadvertently kicks the finish pad resulting in a timing error of several seconds. The Stroke and Turn Judge did not observe this conduct, but the Relay Take-Off Judge on that side of the pool did, and immediately raised his hand. Upon investigation, the Deck Referee is told of the "reentry" violation by the swimmer that the Relay Take-Off Judge observed. The Deck Referee **does not** accept the call. Correct ruling?
