ELIGIBILITY:	<ul> <li>Open to all Virginia Swimming athletes eight years old and younger registered before the first day of the meet</li> <li>No on deck Virginia Swimming athlete registration will be permitted.</li> </ul>		
DISABILITY	<ul> <li>Age on October 18, 2014 will determine age for the entire meet.</li> <li>Athletes with a disability are welcomed and shall provide advance notice of desired</li> </ul>		
SWIMMERS:	accommodations to the Meet Director.		
	The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.		
FORMAT:	All swimmers will swim in one session		
	All events will be timed finals		
	4-minute breaks after each set of events; 10-minute break before the relays		
WARM-UP:	Warm-ups at 11:30 am; competition starts at 12:00 pm.		
	<ul> <li>Lane assignments for individual clubs will be posted on the CGBD website no later than Thursday, October 16, 2014 and will also be emailed to the contact person of the participating clubs.</li> </ul>		
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS WEDNESDAY, OCTOBER 15, 2014		
	Entries must be submitted in Short Course times using Hy-Tek Team Manager and Commlink-2 software, or on a VSI master entry sheet.		
	Teams submit entries via e-mail		
	<ul> <li>A Team Manager printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted.</li> </ul>		
	<ul> <li>Coach Times (CT) and "No Time" (NT) entries will be accepted for events in which a swimmer does not have a time of record. CT may not exceed a "BB" time. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.</li> </ul>		
	Swimmers may enter a maximum of 4 individual events and 1 relay event per day.		
	Relay teams must be designated A, B, C, etc., if more than one per club is entered per event.		
	The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which actions may require reseeding.

	Failure to pay entry fees by this deadline could result in teams being barred from the meet.		
AWARDS:	Individual events: Candy will be awarded for first through sixth place		
	Heat winner Bananas will be awarded for all events.		
	Relay events: Candy will be awarded for first through third place.		
SEEDING:	events will be pre-seeded		
	Swimmers in the afternoon sessions should report directly to the blocks for their events		
PENALTIES:	Penalties for entries using fraudulent and/or non-verifiable entry times:		
	Swimmer shall be marked as exhibition for the event entered illegally and the event shall be re-scored and awarded.		
	<ul> <li>Club may be fined \$100 for each offense, and a record of such offenses shall be kept and published as part of the official meet results.</li> </ul>		
	<ul> <li>Clubs entering swimmers not legally registered with USA Swimming before the first day of the meet may be fined \$100 per swimmer in each event so entered.</li> </ul>		
	<ul> <li>If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.</li> </ul>		
RULES:	The current USA Swimming Rules and Regulations will apply.		
	<ul> <li>Any swimmer entered in the meet must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li> </ul>		
	<ul> <li>Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is not permitted.</li> </ul>		
	Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.		
	<ul> <li>In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet</li> </ul>		
	<ul> <li>Coaches with valid USA Swimming credentials but are unable to provide them upon request will be issued temporary credentials by the meet director</li> </ul>		
	<ul> <li>Coaches with expired or non-current credentials will be required to leave the deck area.</li> </ul>

FACILITY RULES:	PLEASE READ THOROUGHLY. RULES WILL BE ENFORCED BY MEET MARSHALL,     AQUATIC CENTER STAFF AND THE FORT EUSTIS FIRE MARSHALL.		
	FORT EUSTIS AUTOMOBILE ACCESS: DRIVERS LICENSE AND AUTOMOBILE REGISTRATION ARE REQUIRED TO ENTER FORT EUSTIS.		
	<b>Swimmer/Spectator Conduct:</b> Each club is responsible for supervising the conduct of its swimmers/spectators. Any swimmer/spectator who violates Aquatic Center rules, posted at the pool and in the meet program, will be disqualified from the meet and escorted from the facility.		
	• The Aquatic Center prohibits food of any kind in the pool area. Consumption of food is allowed in the lobby area and the spectator balcony. Permissible beverages, sports drinks and water, must be in closed plastic containers.
